

A RESPONSE TO MERYL DOREY'S LETTER OF 7 SEPTEMBER 2009 TO THE HCCC.

Firstly, I should explain why it took me over 6 weeks to respond to Meryl Dorey's attack on me. I was unaware of her letter of 7 September until a week ago, 16 October 2009. The HCCC, in accordance with Meryl Dorey's begging that it not be sent to me, conformed to her request, as is proper. I remained unaware of the untrue defamatory statements made about me until a friend notified me that Meryl Dorey had posted the letter on the AVN website.

So, to expose Meryl Dorey's first piece of hypocrisy, she wrote in her letter:

"I (Meryl Dorey) and the AVN strenuously request that the contents of the attached response be dealt with by the HCCC on a strictly confidential basis and not be provided to Mr McLeod until a final decision has been reached. "And

"I (Meryl Dorey) and the AVN request that the HCCC use the attached response for the purposes of assessing the complaint only, and not be provided to Mr McLeod or any group with which he is associated." And

"I (Meryl Dorey) fear that the provision of our response to him will just generate more hostility and aggression by him towards the AVN."

Then she went and posted it on her website. ¹ Obviously, her appeal to the HCCC to keep the letter from me because of my supposed behaviour was a sham.

Next, Meryl Dorey makes quite defamatory and damaging allegations against me such as:

"Mr McLeod has made numerous direct communications to the AVN and myself via email communication over the last few years, and such communications have been very rude and aggressive in tone and intimidating in nature, particularly towards myself. I have found dealing with this man very distressing and hurtful," and

"the threat that he poses and continues to pose to me and my family is very real...." and

"I can give no explanation for the ferocity with which he pursues both myself and the AVN...."

WOW!! *"Hostility", "aggression", "rude", "aggressive" "intimidating" "threat" "ferocity" "pursues."* These are very serious allegations against me. This is not the first time that Meryl Dorey has defamed me; see her email of Tuesday 1 Tuesday, 1 September 2009 2:52 PM, (attached) in which she says inter alia:

"In conjunction with the HCCC complaint, several anti-AVN websites have sprung into existence, some of them inciting violence against AVN activities and myself." (Dorey), and

"Due to these threats, for the first time in 16 years, we hired a security guard....."

Meryl Dorey's implication, that I was knowingly working in conjunction with people who have incited violence, is very clearly a defamation, and actionable. But wait! as they say, there's more!

In her email, she alleges that;


- I lied: *“Despite his denial of involvement with the Skeptics.....,”*
- I am an atheist and hater: *“.....the non-Skeptics who hate God, complementary health, the AVN and me.....”(Dorey);*
- I am gullible: I *“accept without question anything that is mainstream, drug based, genetically engineered or approved by scientists who often have strong financial links to the products they are recommending.”*
- I am a defamer: my supposed *“slanderous letters written by the author of the HCCC complaint”,*

So this led to my email of 1 September to her in which I said that I entirely rejected all of her baseless allegations, and asked her where I have engaged in threats and intimidation. I also requested that she issue a retraction and apology. My response to her baseless allegations was entirely appropriate. She has never replied to this email.

I do not know why Meryl Dorey makes these allegations against me, except perhaps to gather sympathy and to denigrate my original complaint to the HCCC by denigrating me. So, let us look at the evidence, let us look at the emails she complains of. I have gone back through my records and found the emails, which are attached. (In the last email sent today, I have asked her to confirm that no emails are missing. If I get a response, that will be posted here.) Readers will note that Meryl Dorey’s allegations are baseless, untrue, fabricated, fictitious, mendacious, falsehoods.

Let’s not indulge in euphemisms and allusions here, let’s not beat about the bush; her allegations relating to my behaviour are lies.

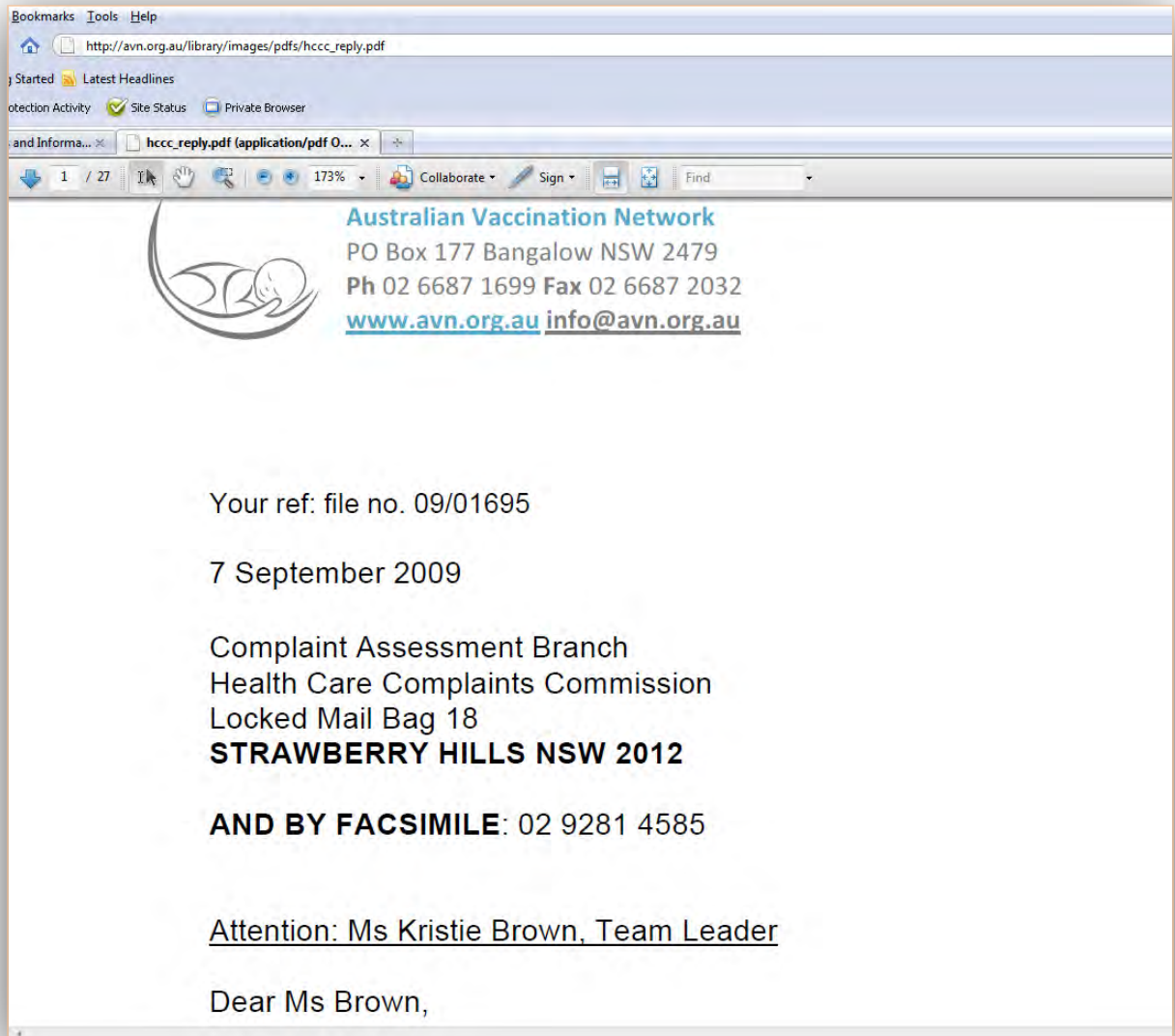

Good afternnon Meryl

I see on your website an article republished from "Natural News" that says:

"The European Medicines Agency (EMA) has reported that two young women died shortly after receiving Merck's Gardasil, a vaccine against several varieties of human papillomavirus (HPV). Letter to politicians - representatives (by the way, if you are not in Australia, you can still use this letter for your own elected representatives since ALL countries are looking at using and perhaps mandating this vaccine).

Dear ,

It has been brought to my attention that Baxter International, a major multi-national pharmaceutical company which has now received contracts from nations all around the world to produce and distribute a new swine flu (H1N1) vaccine, is under suspicion for the following reasons:

1- In February, 2009, Baxter's Austrian branch sent batches of what was supposed to be human influenza (H3N2) vaccine to 18 different European countries. These countries were to use these vaccine samples to produce human flu vaccines for their populations. One country, the Czech Republic, tested these batches and found them to be contaminated with live Avian influenza virus (H5N1 - Bird flu). Had this vaccine been administered to people prior to this contamination being discovered, it could have caused a deadly pandemic.

2- Baxter had been given stocks of Avian influenza virus by the US government so it could work on producing a vaccine against any future outbreak of this disease. This virus was provided to them under the condition that they would adhere to the required Biosafety Level 3 strict controls. Had these controls been followed, this sort of

contamination would have been impossible. There are only 2 conclusions one can draw from the fact that this contamination event took place. Either:

Baxter were incredibly careless with their procedures causing an accidental contamination which then, incredibly, was allowed to get out into millions of doses of vaccine before anyone noticed; or

The contamination was intentional and it was only a matter of luck and good due diligence on the part of the Czech officials that this was caught before anyone received the contaminated vaccine lots.

3- The outbreak of Swine Flu (H1N1) which has led the World Health Organisation (WHO) to declare the highest possible level of pandemic awareness - Level 6 - began in Mexico City - right near a Baxter Labs facility which was working on experimental flu vaccine. This might be no more than a coincidence were it not for the fact that on August 28, 2008, Baxter Labs filed for a patent (# US20090060950A1) on H1N1 virus - almost a full year before this outbreak occurred or H1N1 had ever been heard of! This patent demonstrates that Baxter was working on a vaccine which would have been composed of several different types of viruses including human, pig, dog, horse and avian flu. Is it too much to expect that the company which sent out contaminated flu vaccines in February could not have done exactly the same thing several months later in May?

The New Zealand Minister of Health, the Hon Tony Ryall, has asked Ministry of Health officials to urgently advise him on issues raised about a swine flu vaccine produced by Baxter International Inc. There is grave concern that due to the past record of contamination and errors made by Baxter Labs, none of their vaccines can be trusted.

As a concerned citizen, I agree that there is cause to question Baxter's products and hope that you will also see that there are very serious outcomes possible if a pharmaceutical company, which has been given a contract to make vaccines which will protect health, instead distributes vaccines which spread disease and possibly, even cause death.

It is my will that you do everything within your power to call for a public and transparent investigation of this situation and that any vaccines produced by Baxter International should be thoroughly examined by an independent laboratory for any evidence of contamination with adventitious viruses or bacteria and that the results of this investigation be made public as a matter of urgency.

I thank you for your time and await your prompt response to my letter.



The UK government has pre-ordered 90 million doses of the vaccine and has pushed through the testing (if you can call it that - they aren't even testing the actual vaccine - just a 'mock-up' shot whose composition is not the same) to 5 days and at the end of that time, all will be declared safe and it's time to roll up your sleeve - or else!

After more than 30 years
US District Court issues injunction to stop compulsory vac

Wednesday, August 12th, 2009 - For Immediate Release:

30 years after compulsory vaccination became US Law: *US Court issues an injunction to stop it and to hold the the government and drug companies responsible for reactions.*

A Preliminary Injunction to stop mandatory vaccinations has been issued in the United States District Court of New Jersey. This comes after a federal lawsuit opposing forced vaccines was filed in that court by Tim Vawter, pro se attorney, on July 31st with the federal government as defendant. When the judge signs the Preliminary Injunction, it will stop the federal government from forcing anyone in any state to take flu vaccine against their will. It will also prevent a state or local government from forcibly vaccinating anyone, and forbid any person who is not vaccinated from being denied any services or constitutional rights. Vawter's filings included a Complaint, and several pages of evidentiary Exhibits.

Vawter's legal papers have been written not only for filing in federal court, but additionally so they can be looked at by activists around the world for ideas on filing lawsuits in their own countries to help stop forced vaccinations. Vawter believes that as the truth of the dangers of flu vaccines continues to become known, banning the forced use of them will eventually succeed on a worldwide basis. He cautions people to avoid fear and keep themselves focused on the task of blocking forced vaccination.

Preliminary Injunction will immediately halt mandatory vaccinations in the U.S.

The Court, having heard the Motion for Preliminary Injunction and read the papers in its support, states in the Preliminary Injunction that it appears the federal government has engaged in some amount of negligence with regards to failure to properly investigate the safety of the flu vaccines scheduled for use in late 2009-2010, and the evidence submitted does warrant a more thorough investigation into the safety of the flu vaccines.

The Court ordered that the government shall be forbidden from forcing any person to be required to take any influenza vaccination against that person's free will and free choice. The government will not allow any state or local government, or any party, to force any person to be required to take any influenza vaccination against that person's free will and free choice.

U.S. government sued for gross negligence and violation of the Constitution

In his Cause of Action, Vawter charged that the federal government has engaged in gross negligence by funding and promoting flu vaccines that are proven to be dangerous and manufactured with little oversight. The vaccines scheduled for use in late 2009 and 2010 contain heavy metals including thimerosal mercury, which have been proven to cause autism in children with lowered immune systems, and other dangerous and toxic ingredients. The federal government has stated it will force these flu vaccines onto the American public against their will, under a document signed by Health and Human Services Secretary Kathleen Sebelius.

He further charged that the vaccine makers stand to earn billions of dollars selling vaccines, and are already spending tens of millions advertising a "Phase 6 Pandemic" that the evidence shows does not really exist. The federal government has not required the World Health Organization (WHO) to show evidence of such a pandemic. There has been no collection of facts, sworn testimony, witnesses being questioned, hearings being held, or lie detector tests being given when preposterous statements have been made. The government has failed to investigate profiteering. Billions of dollars in vaccine sales can cause organizations to falsify threats so as to cause unwarranted public hysteria leading to forced vaccinations.

Vawter submitted an Order to force the government to publish vaccine ingredients and side effects, and to give this information to everyone who takes a flu vaccine, and do so at least 3 days prior to their vaccination. A denial of this order would violate Plaintiff's rights to demand the government obey the First Amendment of the U.S. Constitution by requiring it to engage in freedom of speech. The First Amendment not only allows a citizen to have freedom of speech himself, but it allows a citizen to demand his government engage in freedom of speech when it is promoting the use of such as these vaccinations to the public.

The government proclamation stating a person cannot sue for any damages he receives from the flu vaccine, completely bypasses the congress and the court system in violation of the Seventh Amendment of the Constitution which grants the right to sue to recover for damages. Vawter submitted an Order to deem unconstitutional any proclamation, rule or similar law that forbids people from suing for damages resulting from the vaccines of 2009 and 2010.

Dear Meryl,

I am deeply concerned with the contents of your email of Tuesday, 1 September 2009 1:52 PM. To put it succinctly, I regard it as defamatory and actionable, and I give a few examples of such defamation below. To refer to me as the author of the complaint to the HCCC without naming me will not save you from a defamation action: it is widely known that I submitted the complaint, and where I live.

Let me address some of your points.....

You say of me that *"Despite his denial of involvement with the Skeptics.....,"* Let's get the facts right: I never said that I was not involved with the Skeptics, I told you twice by email that *"I am not a member of the Skeptics."* There is a big difference. In this you imply that I am dishonest.

You also say: *".....the non-Skeptics who hate God, complementary health, the AVN and me....."*(Dorey). This is also defamation: I do not "hate God", nor do I "hate complementary health, the AVN" and you. How can you say that? Are you a mind-reader to come to these conclusions? More defamation: you make me appear to be an atheist when I am not, and to be a hateful irrational person when I am not.

Nor as you would have it, do I *"accept without question anything that is mainstream, drug based, genetically engineered or approved by scientists who often have strong financial links to the products they are recommending."* That is pure baseless speculation, and is defamatory in that you are attempting to make me look like a gullible fool and a pawn of the pharmaceutical industry.

As for your paragraph *"In conjunction with the HCCC complaint, several anti-AVN websites have sprung into existence, some of them inciting violence against AVN activities and myself."* (Dorey). The implication that I am knowingly working in conjunction with people who have incited violence is very clearly a defamation, and actionable. For you to say *"Due to these threats, for the first time in 16 years, we hired a security guard....."* shows that you supposedly took the supposed threats very seriously, and so therefore I am a very nasty violent person indeed, and made your "concern" very public, and this compounds the defamation.

As for your paragraph referring to *"slanderous letters written by the author of the HCCC complaint"*, everything I said in my letter was based on quotes from you yourself. To imply that I sullied your reputation with baseless allegations is again defamatory. And for the record, "slander" involves defamation in speech. If you want the word for defamation in writing, you will find "libel" in the dictionary.

As for your paragraph *"I never dreamed that people such as this even existed - let alone that they would stoop to such depths....."* More defamation.

As for your paragraph “.....*any organisation that needs to rely on threats and intimidation to make their point cannot possibly have a legitimate argument.*” Please tell me where I have engaged in threats and intimidation. More defamation.

I entirely reject all of your baseless allegations. They are actionable because they are untrue, are intended to bring me into disrepute and the subject of public hatred and ridicule, and are disseminated to a wide audience. I am deeply hurt and offended.

I request that you issue an email to exactly the same addressees, retracting everything you said of me, and apologise. Your failure to do that will see me referring this matter to my solicitor.
